**SUBJECT: Amending the Board of Port Commissioners' April Meeting Date**

**DESCRIPTION: Adopt a Resolution Amending the Board of Port Commissioners' April 2025 Regular Meeting Date to April 15, 2025**

**EXECUTIVE SUMMARY:**

Section 2 of Board of Port Commissioners (BPC) Policy No. 21 requires that the dates, time and location of the regular meetings of the Board of Port Commissioners of the San Diego Unified Port District be set annually by Resolution. By Resolution No. 2024-081, the BPC established the meeting dates for 2025, including April 8, 2025. Due to scheduling conflicts staff is recommending to change the regularly scheduled April open and closed session meetings to April 15, 2025.

**RECOMMENDATION:**

Adopt a Resolution amending the Board of Port Commissioners' April regular meeting date to April 15, 2025.

**DISCUSSION:**

Establishing regular meeting dates for the year provides the Board of Port Commissioners, the public and other interested parties with advanced notice of upcoming meetings. By Resolution No. 2024-081, the BPC established the meeting dates for 2025, including April 8, 2025. Due to scheduling conflicts staff is recommending to change the regularly scheduled April open and closed session meetings to April 15, 2025.

Any additional meetings that may be necessary during the year will be scheduled and posted as special meetings.

**General Counsel's Comments:**

The Office of the General Counsel has reviewed and approved this agenda and proposed resolution, as presented, as to form and legality.

**Environmental Review:**

The proposed Board action, including without limitation adopting a resolution amending the Board of Port Commissioners' April 2025 regular meeting date to April 15, 2025, does not constitute a project under the definition set forth in California Environmental Quality Act (CEQA) Guidelines Section 15378 because there is not a potential to result in a direct or indirect physical change in the environment. Therefore, the proposed Board action is not subject to CEQA and no further action under CEQA is required.

The proposed Board action complies with Section 21 and 35 of the Port Act, which allow for the Board to pass resolutions and to do all acts necessary and convenient for the exercise of its powers. The Port Act was enacted by the California Legislature and is consistent with the Public Trust Doctrine. Consequently, the proposed Board action is consistent with the Public Trust Doctrine.

The proposed Board action does not allow for development, as defined in Section 30106 of the California Coastal Act, or new development, pursuant to Section 1.a. of the District's Coastal Development Permit Regulations. Therefore, issuance of a Coastal Development Permit or an exclusion finding is not required.
