District and Design Professional are parties to an Agreement for As-Needed Architecture Services. The Agreement is on file in the Office of the District Clerk as Document No. 73480 dated January 19, 2022, as amended by Amendment No. 1, Document No. 74616 dated October 26, 2022 and by Amendment No. 2, Document No. 78124 dated January 30, 2025. It is now proposed to increase the Agreement amount by \$3,000,000.00 from a total of \$1,150,000.00 to a new total not to exceed \$4,150,000.00.

1. Section 3.a., **Maximum Expenditure**, is hereby amended to increase the maximum expenditure under the Agreement by \$3,000,000.00 from a total of \$1,150,000.00 to a new, not to exceed, total amount of \$4,150,000.00.

2. All other Agreement terms, covenants, and conditions shall remain in full force and effect and shall be applicable to this Amendment.
