## AMENDMENT NO. 4 TO AGREEMENT BETWEEN SAN DIEGO UNIFIED PORT DISTRICT and HARRIS & ASSOCIATES, INC. for AS-NEEDED PROJECT MANAGEMENT & CONSTRUCTION MANAGEMENT SERVICES AGREEMENT NO. 75-2021SN

The parties to this Amendment No. 4 to Agreement are the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation (District) and HARRIS & ASSOCIATES, INC., a California Corporation (Design Professional).

# Recitals:

District and Design Professional are parties to an Agreement for As-Needed Project Management & Construction Management Services. The Agreement is on file in the Office of the District Clerk as Document No. 73456 dated January 11, 2022, as amended by Amendment No. 1, Document No. 75678 dated June 26, 2023, by Amendment No. 2, Document No. 75834 dated August 9, 2023, and by Amendment No. 3, Document No. 76185 dated December 7, 2023. It is now proposed to extend the term of the Agreement and to increase the Agreement amount by \$4,200,000.00 from a total of \$11,050,000.00 to a new total not to exceed \$15,250,000.00.

# The Parties Agree:

- 1. The **TERM OF AGREEMENT**, Section 2, is hereby extended to December 31, 2027, subject to earlier termination as provided in the Agreement.
- Section 3.a., Maximum Expenditure, is hereby amended to increase the maximum expenditure under the Agreement by \$4,200,000.00 from a total of \$11,050,000.00 to a new, not to exceed, total amount of \$15,250,000.00.

3. All other Agreement terms, covenants, and conditions shall remain in full force and effect and shall be applicable to this Amendment.

# **Getting paper copies**
