

**AMENDMENT NO. 7 TO AGREEMENT BETWEEN
SAN DIEGO UNIFIED PORT DISTRICT
and
THE REGENTS OF THE
UNIVERSITY OF CALIFORNIA
for
SEA GRANT CALIFORNIA
AGREEMENT NO. 6171-2017**

The parties to this Amendment No. 7 to Agreement are the SAN DIEGO UNIFIED PORT DISTRICT, a public corporation (District) and THE REGENTS OF THE UNIVERSITY OF CALIFORNIA (University).

Recitals:

District and Service Provider are parties to an Agreement for Sea Grant Fellowship. The Agreement is on file in the Office of the District Clerk as Document No. 66057 dated January 19, 2017, as amended by Amendment No. 1 (Document No. 67704 dated January 22, 2018), as amended by Amendment No. 2 (Document No. 69298 dated January 22, 2019), as amended by Amendment No. 3 (Document No. 70822 dated January 16, 2020), as amended by Amendment No. 4 (Document No. 72260 dated March 1, 2021), as amended by Amendment No. 5 (Document No. 73425 dated December 21, 2021), and as amended by Amendment No. 6 (Document No. 74858 dated January 30, 2023). It is now proposed to extend the Agreement from March 31, 2024, to March 31, 2025, to increase the Agreement amount by \$156,051 from a total of \$739,371.53 to \$895,422.53, and to update Exhibit B.

The Parties Agree:

1. The Paragraph entitled **SCHEDULE**, is hereby extended and shall terminate on March 31, 2025.
2. The paragraph entitled **BUDGET**, is hereby increased from \$739,371.53 to \$895,422.53 in order to fund two fellows in 2024.
3. **EXHIBIT B-5**, 2024 Budget Detail, attached hereto, shall be added to Exhibit B.

4. All other Agreement terms, covenants, and conditions shall remain in full force and effect and shall be applicable to this Amendment.
